Instructions

Failure to follow instructions may result in NO payment. Read carefully.

1. Make sure all items are **factory sealed** and have at least **4 months** until expiration. **Items with 1-3 months until expiration will receive a 25% payment. Items that have less than 1 month before expiration or are not factory sealed will be donated and you will not receive compensation for these items.**
2. (OPTIONAL)* Find the items you are selling on this form. **Multiply** the **Quantity** by the item **Price** to get the item **Subtotal**. **Add** the **Subtotals** to get the **Grand Total**.
3. Place the items you are selling in a **box**.
4. Tape our **prepaid shipping label** on the outside of your package.
5. Place this **form** in your package and seal your box.
6. Take your package to your local **USPS Post Office** or have your mail carrier pick it up.

*Step 2 is for your benefit only and can be completed by our staff on your behalf.

Frequently Asked Questions

How long will it take to receive my payment?

We pay within 24 hours of receiving your package (M-F). Business checks typically take 2-5 days to arrive. PayPal and Western Union Instant payments are available immediately after transfer. Bank transfers take 6 business days.

How long will it take my package to arrive once I send it?

If you use our prepaid shipping label transit time is typically 1 week, but can be longer if there are postal delays. Our shipping label has to be manually processed by the post office so that can add several days to transit time. If you choose to purchase postage yourself transit time is 2-5 days for First-Class Mail and 1-3 days for Priority Mail. We do reimburse your postage if you use USPS First-Class or Priority Mail.

The tracking form my package shows delivered, but I haven't been paid?

If you use our shipping label your package is marked delivered when it reaches our neighboring post office where postage is deducted from our account. Once the package is processed (this typically takes 1-2 business days), it is overnighted to us. If you use our shipping label there will be a delay from when your package is marked delivered and when we actually receive it. To avoid this delay purchasing postage and let us reimburse you.

Can you pay me before I send my supplies?

Due to abuse of our prepayment system we no longer offer prepayments.

My supplies expire in less than 4 months, will you still buy them?

Yes. We pay 25% of our full price for supplies expiring within 1 to 3 months.

What makes your company different from other companies that buy test strips?

We do not pay less for mail order boxes or damaged boxes. Our competitors only pay full price for mint condition boxes and your payout will be greatly reduced if your boxes have minor damage. They may also refuse payment completely if your boxes are not in mint condition. Many of our competitors have inflated prices, but never actually pay those prices because they claim the product was damaged on arrival. This will never happen with our company because we don't reduce payment for damaged boxes.

Do you accept donations?

Yes, we welcome donations. If you want to donate, please indicate which items you want to donate on the selling form. If you are donating all items please write DONATION across your selling form.

What if there is a prescription label on my supplies?

We can remove labels for you. All labels we remove are shredded.

Can I get my supplies back after I ship them?

We distribute supplies very quickly so we are rarely able to return supplies. Only sell items you do not need.

Do you discount for damaged boxes?

No. As long as the test strips are factory sealed and there is not a hole large enough to remove items from the box, we will purchase at full price. Please Note: We cannot purchase liquid-damaged supplies.

Do you price match?

We can no longer price match due to a large number of our competitors claiming to pay high prices, but not actually honoring their prices because they claim the boxes sent to them were damaged. Many will pay a fraction of their stated price or refuse to pay, so be careful where you sell your supplies. Always read the Terms and Conditions stated on their website and check their reviews on BBB or other reputable review websites.





Terms and Conditions

Our goal is to purchase diabetic supplies that would otherwise go to waste and make them available to people in need. Do not sell supplies that you need. PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE SELLING YOUR SUPPLIES. By shipping supplies to us, you signify your agreement to these Terms and Conditions.

1. I understand I can only sell supplies that are factory sealed and have at least 4 full months until expiration. I understand I will receive partial payment for supplies with less than 4 months until expiration and no payment for expired supplies or supplies with less than 30 days until expiration. I understand I will receive full payment for boxes that are damaged as long as they are factory sealed with no hole large enough for test strips to be removed and the box has not undergone liquid damage.
2. I am the rightful owner or have been given permission by the rightful owner to sell these supplies to Sell Your Strips for More.
3. I understand I cannot sell supplies that have undergone liquid damage, have been tampered with, or have been otherwise altered. If I attempt to sell supplies that have been tampered with, I understand I will no longer be eligible to sell my supplies to Sell Your Strips for More.
4. If supplies have less than 1 month before expiration, are not factory sealed, have been tampered with or altered, or have undergone liquid damage they will be donated or discarded on my behalf.
5. I am responsible for my package during shipping and Sell Your Strips for More is not responsible for packages that are lost by the U.S. Postal Service. I understand that I should track and insure valuable items.
6. I understand that shipping times vary and while most packages are delivered within a week, some packages may take longer especially near major holidays.
7. I understand I cannot sell test strips have been paid for by Medicare or Medicaid.
8. I agree to transfer all right, title and interest to SellYourStripsForMore.com upon the receipt and inspection of the supplies by SellYourStripsForMore.com.
9. I understand these terms can change at any time.
